To search the electronic AR for PFAS documents, do the following:

Copy: <https://ar.afceec-cloud.af.mil/> into web browser

Select “Continue to site”

Select “Active Duty” at the top left of the page

Scroll down the Installation List and click on “Shaw AFB, SC”

Enter appropriate AR number in the “AR #” field

Click “Search” at the bottom of the page

Click on the “Eye” to view the document
